DAYCARE FORM

Daycare is a cage- free service designed for social dogs to play and have fun. All dog guests will be placed in a group based on their size and temperament. Since safety is our primary goal, daycare is not for every dog. Dogs that are uncomfortable in group settings, have decreased mobility issues, recently undergone a medical procedure, or simply do not play well in a pack would not be the best fit for our Daycare Program.

Reservations are required for staffing purposes. Non- reservation dogs may be turned away if the ratio of dog to staff is reached. Daycare is offered Monday- Friday from 7am- 7pm. We offer daily rates as well as daycare packages. All packages are **non- refundable** and have a **90- day expiration date**.

Requirements:

All daycare dogs must meet the following requirements:

- Complete and sign the Daycare Form
- Be at least 12 weeks of age and have completed the first two series of vaccinations-DHPP, Rabies, Bordetella
- Must meet vaccination requirements listed on the Bark & Bed Guidelines

ASSUMPTION OF RISK:

Owner acknowledges and is aware that the employees of Brewster's Bark & Bed are not veterinarians and are not expected to diagnose or detect illnesses in the dogs utilizing services at Brewster's Bark & Bed. Owner understands that daycare is a leash-free environment that allows dogs the opportunity to play in close physical contact (including nose- to- nose) with each other. Owner further understands that dogs are pack animals, lead with their teeth and paws, and are unpredictable in nature. As a result, no amount of vaccination requirement, supervision, sanitation, or personalized care from Brewster's Bark & Bed can be 100% certain to prevent owner's dog from being injured or contracting an airborne virus or communicable disease. Despite these precautions, owner understands these risks are inherent to the services and hereby releases Brewster's Bark & Bed, its employees or members or other agents, from any and all losses, damages, costs and expenses arising out of or in connection with any injury, communicable disease, airborne virus, or any other medical condition contracted by owner's dog at Brewster's Bark & Bed. This also applies to any claims for injuries or damages related to such medical care or transport. Furthermore, owner agrees to be held solely responsible for any and all acts and behavior of owner's dog while in the care of Brewster's Bark & Bed, including payment of costs for injury to staff or other animals or damage to facilities caused by owner's dog.

Owner's Initials ______ Owner further acknowledges because dogs play and lead with their teeth and paws, injuries including cuts, scrapes, and puncture wounds can be a result of play and not necessarily aggression. Owner agrees to be responsible for all damages and medical treatment for all injuries to dog(s). Owner also understands and acknowledges that if an injury is proven to have occurred due to unprovoked aggression, owner of aggressive dog is responsible for medical treatment of injured dog(s).
